

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Quigley, Tang & Whitehill)**

RESOLUTION NO. 2000-498

1 **WHEREAS, by Resolution 99-593, the Tohono O'odham Legislative Council approved an Attorney**
2 **Contract with the law firm of Quigley, Tang & Whitehill (the "Attorneys") to provide**
3 **legal representation with respect to matters affecting the trust status of the San Lucy**
4 **Farm and litigation and negotiations related to the Central Arizona Project (CAP); and**

5 **WHEREAS, the Attorney Contract expired on September 30, 2000; and**

6 **WHEREAS, the CAP litigation is pending and certain issues regarding the trust status of the San**
7 **Lucy Farm are unresolved; and**

8 **WHEREAS, continued representation regarding ongoing matters is required to protect the**
9 **Nation's interests; and**

10 **WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for**
11 **fiscal year 2001 in the amount of \$15,000; and**

12 **WHEREAS, the operating budget of the Office of Attorney General for fiscal year 2001 includes**
13 **sufficient funding for the Attorney Contract; and**

14 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
15 **an Attorney Contract with the Attorneys on such terms.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
18 **with the law firm of Quigley, Tang & Whitehill in the amount of \$15,000 for the**
19 **fiscal year ending September 30, 2001 and in the form attached hereto.**
- 20 **2. Funding for the Attorney Contract shall be provided under the operating budget**
21 **of the Office of Attorney General for fiscal year 2001.**
- 22 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
23 **Contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**
26 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,957.4 FOR; -0-**
27 **AGAINST; 80.0 NOT VOTING; and 128.1 [03] ABSENT, pursuant to the powers vested in the Council**
28 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
