12	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative Council of				
13		an Attorney Contract with the Attorneys on such terms.				
14	NOW, THEREFORE, BE IT RESOLVED THAT:					
15		1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract				
16		with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom, Schoenburg &				
١7		Enfield, in the amount of \$5,000 for the fiscal year ending September 30, 2001 and				
18		in the form attached hereto.				
19		2. Funding for the Attorney Contract shall be provided under the operating budget				
20		of the Office of Attorney General for fiscal year 2001.				
21		3. The Chairman of the Nation is authorized and directed to execute the Attorney				
22		Contract.
