

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Firm of Slosser, Hudgins, Struse & Freund)

RESOLUTION NO. 2000-500

1 **WHEREAS, an Initiative, No. IN-01-97 (the "Initiative"), was approved by the voters of the Tohono**
2 **O'odham Nation on June 28, 1997; and**

3 **WHEREAS, pursuant to Legislative Council Resolution 99-595, the Nation entered into an**
4 **Attorney Contract with the law firm of Slosser, Hudgins, Struse & Freund (the**
5 **"Attorneys") to assist the Office of Attorney General in assessing the tax implications**
6 **for the Nation and its members associated with the implementation of the Initiative;**
7 **and**

8 **WHEREAS, the Attorney Contract expired on September 30, 2000; and**

9 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
10 **matters; and**

11 **WHEREAS, the Attorney General recommends that the Attorneys be engaged for representation**
12 **in fiscal year 2001; and**

13 **WHEREAS, an Initiative Legal Research budget (the "Budget") in the amount of \$50,000 (Account**
14 **No. 24-1809-810) was approved for fiscal year 2001 for legal costs associated with**
15 **implementation of the Initiative; and**

16 **WHEREAS, the Attorney General has recommended an Attorney Contract with the Attorneys for**
17 **fiscal year 2001 in the amount of \$10,000; and**

18 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
19 **an Attorney Contract with the Attorneys on such terms.**

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 21 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
22 **with the law firm of Slosser, Hudgins, Struse & Freund, in the form attached**
23 **hereto, in the amount of \$10,000 for fiscal year 2001.**
 - 24 **2. Funding for the Attorney Contract shall be provided under the Initiative Legal**
25 **Research budget (24-1809-810).**
 - 26 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
27 **Contract.**
