

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract with Law Firm of Williams, Janov & Cooney)**

RESOLUTION NO. 2000-501

1 WHEREAS, by Resolution 99-596 the Tohono O'odham Legislative Council approved an Attorney  
2 Contract with the law firm of Williams, Janov & Cooney (the "Attorneys") to provide  
3 legal representation with respect to certain of the Nation's water matters; and

4 WHEREAS, the Attorney Contract expired on September 30, 2000; and

5 WHEREAS, continued representation regarding water matters is required to protect the Nation's  
6 interests; and

7 WHEREAS, the Attorney General has recommended an extension of the Attorney Contract for  
8 fiscal year 2001 in the amount of \$20,000; and

9 WHEREAS, the operating budget of the Office of Attorney General for fiscal year 2001 includes  
10 sufficient funding for the Contract; and

11 WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of  
12 an Attorney Contract with the Attorneys on such terms.

13 NOW, THEREFORE, BE IT RESOLVED THAT:

- 14 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract  
15 with the law firm of Williams, Janov & Cooney in the amount of \$20,000 for the  
16 fiscal year ending September 30, 2001 and in the form attached hereto.
- 17 2. Funding for the Attorney Contract shall be provided under the operating budget  
18 of the Office of Attorney General for fiscal year 2001.
- 19 3. The Chairman of the Nation is authorized and directed to execute the Attorney  
20 Contract.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH. Day  
22 of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,926.45 FOR; -0-  
23 AGAINST; 239.05 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
24 Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).




