9	WHEREAS,	the operating budget of the Office of Attorney General for fiscal year 2001 includes
10		sufficient funding for the Contract; and
11	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative Council of
12		an Attorney Contract with the Attorneys on such terms.
13	NOW, THER	EFORE, BE IT RESOLVED THAT:
14		1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract
15		with the law firm of Williams, Janov & Cooney in the amount of \$20,000 for the
16		fiscal year ending September 30, 2001 and in the form attached hereto.
17		2. Funding for the Attorney Contract shall be provided under the operating budget
18		of the Office of Attorney General for fiscal year 2001.
19		3. The Chairman of the Nation is authorized and directed to execute the Attorney
20		Contract.
