

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 2000 Title XX - Child Day Care Budget July 01, 2000 - June 30, 2001)**

**RESOLUTION NO. 2000-503**

1 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**  
2 **members by providing for their welfare through various programs service designed**  
3 **to meet special needs; and**

4 **WHEREAS, the Child Day Care Services Program has been successfully operated through the**  
5 **Early Childhood Division and has served many Tohono O'odham Children; and**

6 **WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this program for**  
7 **the benefit of its young members.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**  
9 **hereby approve the proposed Budget for FY 2000 - 2001 Title XX Child Day Care**  
10 **Services in the amount of \$145,988.00, and authorizes the expenditure of funds in**  
11 **accordance with the attached budget as presented by the Tohono O'odham Education**  
12 **Department.**

13 **BE IT FURTHER RESOLVED that the duration of the Budget will be from July 01, 2000 - June**  
14 **30, 2001.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
16 **O'odham Nation's Officials, to wit: the Chairman and any designated official are**  
17 **hereby authorized to negotiate and execute the contract, provided however, that any**  
18 **amendments affecting the funding levels of this contract shall be submitted for**  
19 **further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day**  
21 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**




