

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating the sum of \$102,310.00 to complete the Visa/Passport Project)

RESOLUTION NO. 2000-510

1 **WHEREAS, members of the Nation residing in Mexico are unable to enter the United States to**
2 **obtain health care and other services, participate in cultural and/or religious events,**
3 **visit family members and/or conduct personal business; and**

4 **WHEREAS, members of the Nation residing in Mexico who have entered the United States without**
5 **documentation have been subjected to arrest, deportation, seizure of their vehicles**
6 **and in some cases criminal prosecution; and**

7 **WHEREAS, the Executive has negotiated an agreement with the American and Mexican Consuls**
8 **to waive certain documentary requirements and issue members of the Nation**
9 **Mexican passports and American visas; and**

10 **WHEREAS, the Legislative Council finds that it is in the best interest of the Nation to obtain**
11 **Mexican passports and American visas for members residing in Mexico.**

12 **NOW, THEREFORE, BE IT RESOLVED that:**

- 13 **1. The sum of \$102,310.00 is hereby appropriated to pay for processing fees and**
14 **related expenses associated with obtaining Mexican passports and American visas**
15 **for the one thousand two hundred thirty-eight (1,238) members residing in Mexico**
16 **for whom these documents have not been processed.**
- 17 **2. The Executive is authorized and instructed to conduct this activity and expend**
18 **funds appropriated herein required to obtain passports and visas for the**
19 **members residing in Mexico.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH, Day**
21 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,176.7 FOR; 725.9**
22 **AGAINST; 104.8 NOT VOTING; and 158.1 [03] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (c)(2), (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
26 **of June 18, 1934 (48 Stat. 984).**


