

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2001 Budget for the Child Care Services for Grant Year 2001 Fund)

RESOLUTION NO. 2000-518

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head Start**
2 **Center and Child Care Centers for its young members and providing for their welfare**
3 **through various programs and services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
5 **Families has awarded the Tohono O'odham Nation a total of \$574,808.00 to**
6 **implement a Child Care Services Program; and**

7 **WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child Care**
8 **Services to its young tribal members; and**

9 **WHEREAS, the Child Care Services of the Tohono O'odham Nation has submitted for review and**
10 **approval the proposed Grant Year 2001 Funds.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
12 **approve the Child Care Services Budget for:**

13 **Grant Year 2001 - Discretionary Funds for Administrative Cost in the amount of**
14 **\$60,866.00; and**

15 **Grant Year 2001 - Discretionary Funds for Program Cost in the amount of**
16 **\$104,279.00; and**

17 **Grant Year 2001 - Mandatory Funds for Administrative Cost in the amount of**
18 **\$87,358.00; and**

19 **Grant Year 2001 - Mandatory Funds for Program Cost in the amount of \$322,305.00.**

20 **BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 2000 to**
21 **September 30, 2001.**

22 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation's Officials to wit: the Chairman, and any designated officials are hereby**
24 **authorized to negotiate and execute the grant.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
27 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 1,935.55 FOR; 80.0**
28 **AGAINST; 149.95 NOT VOTING; and 0 ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**


