

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2001 Attorney Contracts for: David M. Juarez, Lawrence O. Boswell and
David K. Kovalik to serve as Conflict Attorneys)

RESOLUTION NO. 2000-519

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain David M. Juarez, Lawrence O. Boswell and**
5 **David K. Kovalik to be appointed to represent clients with conflicts of interest who**
6 **can not be represented by the Nation's Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for David M. Juarez, Lawrence O.**
8 **Boswell and David K. Kovalik which confirms and ratifies the terms and conditions**
9 **related to their services, a copy of which is attached; and**

10 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
11 **an Attorney Contract with David M. Juarez, Lawrence O. Boswell and David K. Kovalik**
12 **on such terms.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 14 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**
15 **Attorney Contracts for David M. Juarez, Lawrence O. Boswell and David K. Kovalik**
16 **in the forms attached hereto, for the period of October 01, 2000 through**
17 **September 30, 2001 in the amount not to exceed \$27,000.00 per contract or**
18 **\$81,000.00 total.**
- 19 **2. Funding for the Conflict Attorney Contracts for David M. Juarez, Lawrence O.**
20 **Boswell and David K. Kovalik shall be provided under the operating budget of the**
21 **Advocate Program for Fiscal Year 2001.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
24 **of OCTOBER, 2000 at a meeting at which a quorum was present with a vote of 2,086.45 FOR; -0-**
25 **AGAINST; 79.05 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
26 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**




