4 **National Congress of American Indians; and**

5 **WHEREAS, the Tohono O'odham Legislative Council believes it is in the best interest of the**
6 **Tohono O'odham Nation to renew its membership in the National Congress of**

6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).


