

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Head Start Federal Budget)**

RESOLUTION NO. 2000-545

1 **WHEREAS, the Tohono O'odham Nation has operated a Head Start Program to provide**
2 **educational, health, mental health, and parent involvement services for children**
3 **three to five years of age; and**

4 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**
5 **Families provides funds for the continued operation of the Head Start Program; and**

6 **WHEREAS, the Head Start program has prepared a funding proposal to be submitted to the U.S.**
7 **Department of Health and Human Services, Administration for Children and**
8 **Families.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
10 **that it does hereby approve the Tohono O'odham Nation Head Start Fiscal Year 2001**
11 **budget in the amount of \$60,731.14 for Administration Cost and \$1,285,648.86 for**
12 **Program Cost for a grand total FY 2001 Head Start award of \$1,346,379.00.**

13 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation's officials to wit: the Chairman, Vice Chairman and any designated official are**
15 **hereby authorized to negotiate and execute the grant provided that any amendments**
16 **affecting the funding or funding levels of this grant shall be submitted for approval**
17 **by this Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
19 **of November 2000 at a meeting at which a quorum was present with a vote of 1999.6 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 165.9 [07] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**




