

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval for Request for Extension of Time on Bureau of Reclamation Grant  
Agreement No. 6-FG-32-00100 for Schuk Toak Farm Construction)**

**RESOLUTION NO. 2000-551**

1 **WHEREAS, the Tohono O'odham Nation entered into a Public Law 93-638 Grant Agreement with**  
2 **the Bureau of Reclamation, Agreement No. 6-FG-32-00100, for the construction of a**  
3 **distribution system for delivery of Central Arizona Project Water to the Schuk Toak**  
4 **District of the Tohono O'odham Nation in December 1995; and**

5 **WHEREAS, the original term of four years has been extended to five years, and a total of**  
6 **\$23,075,452.64 has been made available for construction of the project; and**

7 **WHEREAS, the current expiration date of the Grant Agreement is December 31, 2000; and**

8 **WHEREAS, the Nation's Water Projects Office and the Farm Authority Board have estimated that**  
9 **several more months will be needed to complete construction of the project,**  
10 **including well drilling, ecological mitigation and close-out activities, and have**  
11 **recommended extension of the Grant Agreement for an additional nine months until**  
12 **September 30, 2001; and**

13 **WHEREAS, the remaining work projected can be completed using the carry-over funds from the**  
14 **existing Agreement; and**

15 **WHEREAS, this matter has been reviewed by the Budget and Finance Committee and is**  
16 **recommended for approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
18 **extension of Bureau of Reclamation Grant Agreement No. 6-FG-32-00100 for an**  
19 **additional nine months until September 30, 2001, with no change in the amount of**  
20 **funds, and authorizes and directs the Chairman of the Nation to negotiate and**  
21 **execute an extension to the Grant Agreement.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
23 **of December 2000 at a meeting at which a quorum was present with a vote of 2,005.5 FOR; -0-**  
24 **AGAINST; 160.0 NOT VOTING; and [04] ABSENT pursuant to the powers vested in the Council by**  
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
