### **RESOLUTION NO. 2000-551**

1	WHEREAS,	the Tohono O'odham Nation entered into a Public Law 93-638 Grant Agreement with						
2		the Bureau of Reclamation, Agreement No. 6-FG-32-00100, for the construction of a						
3		distribution system for delivery of Central Arizona Project Water to the Schuk Toak						
4		District of the Tohono O'odham Nation in December 1995; and						
5	WHEREAS,	the original term of four years has been extended to five years, and a total of						
6		\$23,075,452.64 has been made available for construction of the project; and						
7	WHEREAS,	the current expiration date of the Grant Agreement is December 31, 2000; and						
8	WHEREAS,	the Nation's Water Projects Office and the Farm Authority Board have estimated that						
9		several more months will be needed to complete construction of the project,						
10		including well drilling, ecological mitigation and close-out activities, and have						
11		recommended extension of the Grant Agreement for an additional nine months until						
12		September 30, 2001; and						
13	WHEREAS,	the remaining work projected can be completed using the carry-over funds from the						
14		existing Agreement; and						
15	WHEREAS,	this matter has been reviewed by the Budget and Finance Committee and is						
16		recommended for approval.						
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves							
18		extension of Bureau of Reclamation Grant Agreement No. 6-FG-32-00100 for an						
19		additional nine months until September 30, 2001, with no change in the amount of						
20		funds, and authorizes and directs the Chairman of the Nation to negotiate and						
21		execute an extension to the Grant Agreement.
