

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating and Authorizing the FY 2001 General Support Services Supplemental
Budget in the Amount of \$1,004,710.75 from the Nation's 638 Interest Income)**

RESOLUTION NO. 2000-557

1 WHEREAS, the Tohono O'odham Nation receives advance funding for its 638 contracts and the
2 interest income on these funds are available for use by the Nation for its Indirect Cost
3 Pool; and

4 WHEREAS, approximately \$1,015,000 of interest income has been identified for which the
5 Executive Branch has prepared and presented the FY 2001 General Support Services
6 Supplemental Budget, attached and incorporated into this resolution; and

7 WHEREAS, the Legislative oversight committees have reviewed the attached budget and
8 recommend approval.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the FY
10 2001 General Support Services Supplemental Budget as attached is hereby approved
11 and authorized.

12 BE IT FURTHER RESOLVED that the source of the appropriation in the amount of \$1,004,710.75
13 shall be from interest income on the Nation's 638 account.

14 BE IT FINALLY RESOLVED that the personnel and operational costs shall be made a part of each
15 respective program's base.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day
17 of DECEMBER 2000 at a meeting at which a quorum was present with a vote of 1,895.75 FOR; -0-
18 AGAINST; 269.75 NOT VOTING; and [03] ABSENT pursuant to the powers vested in the Council by
19 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
20 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22 18, 1934 (48 Stat. 984).


