

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2001 Legislative Branch Budget)**

RESOLUTION NO. 2000-564

1 **WHEREAS, on October 25, 2000, the Legislative Council enacted Resolution No. 2000-508,**
2 **"Incorporating Legislative Council Compensation into the FY 2001 Interim Legislative**
3 **Branch Budget"; and**

4 **WHEREAS, the Legislative Council passed Resolution No. 2000-402 which required a 30-day**
5 **public comment period before acting on Council's compensation increases; and**

6 **WHEREAS, the public hearing presentations to the Districts have been completed and the**
7 **Legislative Branch has awaited responses to the November 1, 2000 memorandum**
8 **forwarded to all the Districts requesting additional comments; and.**

9 **WHEREAS, the 30-day public comment period required by Tohono O'odham Legislative Council**
10 **Resolution No. 2000-402 is now complete; and**

11 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval their FY**
12 **2001 Budget to the Budget and Finance Committee; and**

13 **WHEREAS, the Legislative Council has reviewed the FY 2001 Legislative Branch Budget.**

14 **NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council hereby**
15 **approves the FY 2001 Legislative Branch Budget in the amount of \$3,724,509.00.**

16 **BE IT FURTHER RESOLVED that funds in the amount of \$3,724,509.00 are appropriated and**
17 **authorized to be expended from sources of funding approved by this Council for**
18 **support of the FY 2001 budgets of the Tohono O'odham Nation.**

19 **BE IT FINALLY RESOLVED that this resolution and attached budgets supercede all previously**
20 **adopted FY 2001 Legislative Branch budgets.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
22 **of DECEMBER 2000 at a meeting at which a quorum was present with a vote of 1,025.3 FOR; 968.4**
23 **AGAINST; 171.8 NOT VOTING; and [05] ABSENT pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**




