

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Reauthorization of the Tohono O'odham Department of Human Services/Developmental Disability Assistance - FY 2001 Tribal Budget Amendment #1)**

RESOLUTION NO. 2000-572

1 WHEREAS, the Tohono O'odham Department of Human Services is presently operating the  
2 Developmental Disability Assistance Program through approved tribal funding; and  
3 WHEREAS, a budget amendment has been submitted which reauthorizes the carry forward  
4 amount of \$32,549.00 from FY 2000 to FY 2001 to establish a Capital Equipment line  
5 item to cover the cost of a purchased handicap van in the year 2000.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
7 approves:

- 8 1. The reauthorization to carry forward \$32,549.00 from FY 2000 to FY 2001 to  
9 establish a Capital Equipment line item to cover the cost of a purchased handicap  
10 van in the fiscal year 2000.  
11 2. The attached FY 2001 Developmental Disability Assistance Budget Amendment #1  
12 as reflected in the attached budget.


13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day  
14 of DECEMBER 2000 at a meeting at which a quorum was present with a vote of 1,929.65 FOR; -0-  
15 AGAINST; 235.85 NOT VOTING; and [04] ABSENT pursuant to the powers vested in the Council by  
16 Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
17 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat. 984).
