

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Livestock Facility Program to Expend Funds from Revenue
Account #44-1510-408)**

RESOLUTION NO. 2000-575

1 **WHEREAS, the Livestock Facility Program is under the direction of the Natural Resources**
2 **Department; and**

3 **WHEREAS, Resolution No. 99-204 was passed in May 1999 establishing Account No. 44-1510-408**
4 **for the deposit of revenues from the sale of hay at the Livestock Facility; and**

5 **WHEREAS, Resolution No. 99-204 establishes that the proceeds from Revenue Account No. 44-**
6 **1510-408 could be expended to fund a Livestock Yard Attendant, to pay for the hay**
7 **sold, and to fund the service, maintenance, and upgrade of the Livestock Complex**
8 **and Complex equipment; and**

9 **WHEREAS, the Livestock Facility Program is striving to expend funds for the purposes**
10 **established in Resolution No. 99-204; and**

11 **WHEREAS, the Livestock Facility Program sold 13,262 bales during FY 2000; and**

12 **WHEREAS, the total profit from the sale of alfalfa hay for FY 2000 was \$20,376.82 with an average**
13 **profit of \$1.54 per bale; and**

14 **WHEREAS, the estimated sales of hay for FY 2001 is 14,000 bales with a profit of \$1.79 per bale and**
15 **an expected monthly profit of \$2,000.00. The total FY 2001 profit is estimated at**
16 **\$24,000.00.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 18 **1. The attached budget in the amount of \$17,739.84 for the purpose of expending**
19 **funds from revenue account #44-1510-408 is hereby approved.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
21 **of DECEMBER 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**


