

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Water Permit for Granite Construction Company for Construction
of Vamori Bridge)

RESOLUTION NO. 2000-576

1 **WHEREAS, Granite Construction Company has contracted with the Bureau of Indian Affairs**
2 **to perform construction of the Vamori Bridge in Chukut Kuk District; and**
3 **WHEREAS, Granite Construction Company has requested use of water from an existing well**
4 **in Chukut Kuk District; and**
5 **WHEREAS, under the Constitution of the Tohono O'odham Nation, the Nation has the**
6 **authority to regulate water use and to issue water permits; and**
7 **WHEREAS, the Tohono O'odham Nation agrees to grant a water permit to Granite**
8 **Construction Company to extract water from the East Well near Vamori Wash in**
9 **Chukut Kuk District for bridge construction purposes, to be paid for at the rate of**
10 **\$1.85 per 1,000 gallons to be paid to the Nation and to be allocated 55% to the**
11 **Tohono O'odham Nation and 45% to Chukut Kuk District, which water withdrawal**
12 **will be monitored by Chukut Kuk District and the Nation's Natural Resources**
13 **Department; and**
14 **WHEREAS, the attached Water Permit has been reviewed and approved by the Chukut Kuk**
15 **District Council and by the Legislative Council Water Resources Committee and is**
16 **recommended for approval by the Legislative Council.**
17 **NOW, THEREFORE, BE IT RESOLVED that the "Water Permit for Water Extraction, Chukut Kuk**
18 **District, Tohono O'odham Nation" is hereby approved by the Tohono O'odham**
19 **Legislative Council in the form attached hereto, and the Chairman of the Nation**
20 **is authorized and directed to sign it on behalf of the Nation.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH, day of**
22 **DECEMBER, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (i)(2) of Article VI and Section 2 (c) of Article XVII of the Constitution of the Tohono**
25 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**
26 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
27 **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
