

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Annual Membership in the Arizona Indian Gaming Association)**

RESOLUTION NO. 2000-578

1 **WHEREAS, the Tohono O'odham Legislative Council has delegated oversight on Indian gaming**
2 **issues to the Commerce Committee; and**

3 **WHEREAS, the Arizona Indian Gaming Association (AIGA) is an association of those tribes**
4 **located in the State of Arizona which have gaming interests, and represents those**
5 **interests before local, state and federal government agencies, the media, and**
6 **other public and private groups; and**

7 **WHEREAS, the AIGA requires an annual fee for membership, which has been set at \$35,077 for**
8 **2000-2001 for the Tohono O'odham Nation; and**

9 **WHEREAS, the Tohono O'odham Nation has been a member of AIGA since its inception; and**

10 **WHEREAS, the Commerce Committee recommends that the Tohono O'odham Nation renew**
11 **its membership in the AIGA.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **authorizes payment of the AIGA membership fee in the amount of \$35,077, and that**
14 **such fee shall be an operating cost of the Desert Diamond Casino.**

15 **The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day of**
16 **DECEMBER, 2000 at a meeting at which a quorum was present with a vote of 1,531.3 FOR; 506.1**
17 **AGAINST; -0- NOT VOTING; and 128.1 [05] ABSENT, pursuant to the powers vested in the Council**
18 **by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
