

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(P.L. 106-25 - Authorization of Acceptance and Expenditure of Funds - Law Enforcement)**

RESOLUTION NO. 01-016

1 **WHEREAS, the Tohono O'odham Nation shares approximately seventy-five (75) miles of**
2 **international border with Mexico; and**

3 **WHEREAS, the Nation's proximity to the international border in conduction with the well-**
4 **documented transit of undocumented aliens into the United States from Mexico has**
5 **created a tremendous burden to the Tribe in both direct expenditures and lost**
6 **opportunity costs; and**

7 **WHEREAS, the Tohono O'odham Police Department requested funding allocated by P.L. 106-25**
8 **in the amount of \$144,000.00 to facilitate the purchase of durable goods and**
9 **equipment that will provide assistance in addressing the above mentioned challenge;**
10 **and**

11 **WHEREAS, the Tohono O'odham Police Department is requesting that indirect costs for the**
12 **administration of this grant, totaling \$11,264.05 be waived; and**

13 **WHEREAS, these funds will not be fully utilized in fiscal year 2000 due to time constraints but will**
14 **continue till the end of fiscal year 2001.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the acceptance and expenditure of funds granted by P.L. 106-25.**

17 **BE IT FURTHER RESOLVED that the 17.4% indirect cost, totaling \$11,264.05 is thereby waived.**

18 **BE IT FINALLY RESOLVED that the balances as identified by the attached budget, in the amount**
19 **of \$144,000.00 are hereby accepted in Fiscal Year 2000 and continued through to**
20 **September 30, 2001.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
22 **of JANUARY, 2001 at a meeting at which a quorum was present with a vote of 1,493.2 FOR; 567.5**
23 **AGAINST; 104.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
