

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of Arizona State Grants-in Aid for Tribal Libraries from the Arizona  
State Library, Archives, and Public Records Department for the Venito Garcia  
Library and Archives)**

**RESOLUTION NO. 01-021**

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation has traditionally supported the**  
2 **Library activities of the Venito Garcia Library and Archives; and**

3 **WHEREAS, if awarded, accepts the State Grant-in Aid for Tribal Communities funds from the**  
4 **Arizona State Library, Archives, and Public Records Department for the Library to**  
5 **conduct basic archival work on the Nation's archival records; and**

6 **WHEREAS, a local funding match will be contributed in the areas of Equipment and 20% of the**  
7 **Librarian and Archivist's Salary from the Programs Tribal budget.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the proposed budget of \$2,425.00 for this purpose, and hereby authorizes the**  
10 **expenditure of funds in accordance with this budget by the Venito Garcia Library and**  
11 **Archives.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
14 **of JANUARY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
19 **Stat. 984).**
