

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Re-authorization of \$30,000 for the Department of Information and Technology)**

RESOLUTION NO. 01-024

1 **WHEREAS, during fiscal year 2000 the Tohono O'odham Legislative Council did by Resolution No.**
2 **2000-358 approve a modification of the Department of Information and Technology**
3 **budget to provide for the purchase of replacement computers and related**
4 **equipment; and**

5 **WHEREAS, the delivery of such equipment was received after the close of fiscal year 2000; and**

6 **WHEREAS, it is now required that the Council re-authorize the funds provided under the budget**
7 **modification to provide for proper payment of the equipment.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
9 **re-authorize the use of identified funds as provided in Resolution No. 2000-358 for the**
10 **purchase of replacement computers and related equipment.**

11 **BE IT FURTHER RESOLVED that the attached budget amendment of the Department of**
12 **Information and Technology incorporating the re-authorization provided above is**
13 **hereby approved.**

16 **of JANUARY, 2001 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 128.1 [05] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
