7	WHEREAS,	the TERO Commission Chairman, the TERO Director/Administrator, the Office of						
8		Attorney General and the Domestic Affairs Committee agree that the effective date						
9		should not predate the enactment of the wage determination, and that the effective						
10		date should instead be the date of approval of the resolution by the Chairman of the						
11		Nation.						
12	NOW, THEREFORE, BE IT RESOLVED that Resolution No. 01-028 is hereby amended to change the							
13		effective date in Section 2 of the wage determination from August 1, 2000 to the date						
14	of approval by the Chairman of the Nation of the resolution adopting the wage							
15		determination.
