

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Legislative Council Resolution No. 01-028 Regarding a Wage**  
**Determination for the Nation)**

**RESOLUTION NO. 01-030**

1 **WHEREAS, on January 10, 2001 the Tohono O'odham Legislative Council passed Resolution No.**  
2 **01-028 entitled "Adopting a Wage Determination for Commercial Construction,**  
3 **Residential Construction, and Heavy Construction projects within the boundaries of**  
4 **the Tohono O'odham Nation;" and**

5 **WHEREAS, the text of the resolution erroneously contained reference to an effective date of**  
6 **August 1, 2000; and**

7 **WHEREAS, the TERO Commission Chairman, the TERO Director/Administrator, the Office of**  
8 **Attorney General and the Domestic Affairs Committee agree that the effective date**  
9 **should not predate the enactment of the wage determination, and that the effective**  
10 **date should instead be the date of approval of the resolution by the Chairman of the**  
11 **Nation.**

12 **NOW, THEREFORE, BE IT RESOLVED that Resolution No. 01-028 is hereby amended to change the**  
13 **effective date in Section 2 of the wage determination from August 1, 2000 to the date**  
14 **of approval by the Chairman of the Nation of the resolution adopting the wage**  
15 **determination.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
18 **of JANUARY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (c) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
