5		by the Tohono O'odham Council."; and
6	WHEREAS,	the Legislative Council may adopt internal rules and procedures, including
7		${\bf procedures for the appoint ment of the judges to the Tohono O'odham Judicial Court;}$
8	,	and
9	WHEREAS,	by Legislative Order No. 01-040, the Legislative Council has adopted the "Judicial
10		Appointment Procedure" to establish a consistent and equitable process for
11		appointing qualified candidates to the Tohono O'odham Judicial Court bench; and
12	WHEREAS,	pursuant to Section 4.D.1. of the Judicial Appointment Procedure, the Legislative
13		Council "shall conduct a preliminary vote of support for each candidate. One vote,
14		$recorded\ in\ the\ form\ of\ a\ legislative\ order\ for\ each\ candidate, shall\ be\ taken\ for\ each$
15		candidate separately."; and
16	WHEREAS,	on this 25^{th} day of January 2001 , the Legislative Council has interviewed all judicial
17		candidates who have submitted complete applications and who have appeared
18		before the Council; and
19	WHEREAS,	${\bf VioletLui-Frankhassubmittedacompleteapplicationform, otherdocumentsand}$
20		information as required by the Judiciary Committee, and has appeared before and
21		been interviewed by the Judiciary Committee and the Legislative Council; and
22	WHEREAS,	the Legislative Council has taken a preliminary vote of support for Violet Lui-Frank
23		for the limited purpose of determining the order in which this candidate shall be
24		considered during the final certification voting process pursuant to Section 4.F. of
25		the Judicial Appointment Procedure; and
26	WHEREAS,	Violet Lui-Frank has received the number of preliminary votes recorded in this
27		Legislative Order.
28	NOW, THERE	FORE, BE IT ORDERED by the Tohono O'odham Legislative Council that, pursuant to
29		Section 4.D.5. of the Judicial Appoint ment Procedure, the preliminary vote recorded
30		herein shall not be considered a final certification, nomination, or appointment to
