

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Recording Preliminary Vote in Support of Judicial Candidate Linda Carlos)**

**LEGISLATIVE ORDER NO. 01-043**

- 1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint judges**  
2 **to the Tohono O'odham Judicial Court pursuant to Section 3 of Article VIII of the**  
3 **Constitution of the Tohono O'odham Nation, which states, "The Tohono O'odham**  
4 **Courts shall be courts of record and shall consist of at least six (6) judges appointed**  
5 **by the Tohono O'odham Council."; and**
- 6 **WHEREAS, the Legislative Council may adopt internal rules and procedures, including**  
7 **procedures for the appointment of the judges to the Tohono O'odham Judicial Court;**  
8 **and**
- 9 **WHEREAS, by Legislative Order No. 01-040, the Legislative Council has adopted the "Judicial**  
10 **Appointment Procedure" to establish a consistent and equitable process for**  
11 **appointing qualified candidates to the Tohono O'odham Judicial Court bench; and**
- 12 **WHEREAS, pursuant to Section 4.D.1. of the Judicial Appointment Procedure, the Legislative**  
13 **Council "shall conduct a preliminary vote of support for each candidate. One vote,**  
14 **recorded in the form of a legislative order for each candidate, shall be taken for each**  
15 **candidate separately."; and**
- 16 **WHEREAS, on this 25<sup>th</sup> day of January 2001, the Legislative Council has interviewed all judicial**  
17 **candidates who have submitted complete applications and who have appeared**  
18 **before the Council; and**
- 19 **WHEREAS, Linda Carlos has submitted a complete application form, other documents and**  
20 **information as required by the Judiciary Committee, and has appeared before and**  
21 **been interviewed by the Judiciary Committee and the Legislative Council; and**
- 22 **WHEREAS, the Legislative Council has taken a preliminary vote of support for Linda Carlos for**  
23 **the limited purpose of determining the order in which this candidate shall be**  
24 **considered during the final certification voting process pursuant to Section 4.F. of**  
25 **the Judicial Appointment Procedure; and**
- 26 **WHEREAS, Linda Carlos has received the number of preliminary votes recorded in this**  
27 **Legislative Order.**
- 28 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that, pursuant to**  
29 **Section 4.D.5. of the Judicial Appointment Procedure, the preliminary vote recorded**  
30 **herein shall not be considered a final certification, nomination, or appointment to**
