1	WHEREAS,	the To hono O' od ham Legislative Council is vested with the power to appoint members
2		of the Tohono O'odham Election Board pursuant to Section 1(B) of Article II of
3		Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"), which
4		states, "Members of the Election Board shall be appointed by the Tohono O'odham
5		Council for terms of five years, or until their successors are appointed and qualified";
6		and
7	WHEREAS,	the Election Ordinance further requires "that appointments to the board shall be
8		made in such a way and for such terms that their terms shall be staggered so that the
9		term of office of only one member will end in any single year."; and
10	WHEREAS,	effective July 31, 2000, Election Board Member Matilda Juan's term did expire and she
11		continues to serve as a Board member until her successor is appointed; and
12	WHEREAS,	in compliance with the Election Ordinance, the Legislative Council has the duty to
13		appoint a successor who will complete the five year term that is currently held by
14		Matilda Juan and which will expire July 31, 2005; and
15	WHEREAS,	the Rules Committee, having legislative oversight over the Election Board, has
16		reviewed the Election Board's recommendations concerning this appointment and
17		has, furthermore, interviewed qualified bilingual members of the Nation to fill this
18		seat on the Election Board; and
19	WHEREAS,	the Rules Committee has reported its findings concerning this appointment to the
20		Legislative Council and has recommended that Matilda Juan be reappointed to the
21		Election Board and complete the five year term ending July 31, 2005.
22	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
23		reappoints Matilda Juan as a member of the Election Board to complete the five (5)
24		year term ending July 31, 2005.
