

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling the Economic Development Authority Charter until the April 2001 General
Session or upon completion of revisions to the Economic Development Authority
Charter)**

LEGISLATIVE ORDER NO. 01-056

1 **WHEREAS, on February 06, 2001 the Economic Development Task Force made a presentation to**
2 **the Tohono O'odham Legislative Council on the Economic Development Authority**
3 **Charter; and**

4 **WHEREAS, concerns were raised by the Council regarding interim board members, changes to**
5 **the Charter and other recommendations.**

6 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby tables**
7 **the Economic Development Authority Charter until the April 2001 General Session or**
8 **upon completion of revisions to the Economic Development Authority Charter.**

9 **BE IT FURTHER ORDERED that the Economic Development Task Force consider the following**
10 **recommendations made by the Legislative Council with regard to the Economic**
11 **Development Authority Charter:**

12 **1. To delete paragraph 3 in Section 5 of the Charter.**

13 **[The Legislative Council may appoint an Interim Economic Development Board**
14 **to serve until the Economic Development Board is confirmed. The Interim**
15 **Economic Development Board shall function as the Economic Development**
16 **Board in all respects for the period of their appointment or until the Economic**
17 **Development Board is confirmed under SECTION 5. The membership**
18 **requirements of section 5(a), below, are waived for appointments to the Interim**
19 **Economic Development Board.]**

21 **2. To change may to shall on Section 5(a)3(E).**

22 **[Employees of the Authority, and elected officials may *shall* not serve in the**
23 **capacity of Director of the Economic Development Board.]**

25 **3. To house all the Economic Development Programs under the Economic**
26 **Development Authority**

28 **BE IT FINALLY ORDERED that the Task Force and other parties will hold meetings on the**
29 **recommendations prior to final presentation to the Legislative Council.**

31 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH. Day of**
32 **FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 1,640.9 FOR; 364.6**
33 **AGAINST; -0- NOT VOTING; and 160.0 [08] ABSENT, pursuant to the powers vested in the Council by**
34 **Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
35 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
36 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
37 **18, 1934 (48 Stat. 984).**


