

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Revised FY 2001 Budget for the Tohono O'odham Judicial Branch**  
**Resolution No. 2000-355 from \$5,271,380.00 to \$5,008,830.00)**

RESOLUTION NO. 01-059

1 WHEREAS, the Tohono O'odham Legislative Council on August 09, 2000 appropriated  
2 \$5,271,380.00 under Resolution No. 2000-355 in support of the FY 2001 Judicial  
3 Branch; and

4 WHEREAS, under the direction of the Legislative Budget and Finance Committee, which had  
5 determined that within the 93-638 budget there existed a savings of \$262,550.00,  
6 advised the Judicial Branch to revise the approved FY 2001 Budget to reflect  
7 transferring this amount to the FY 2001 Judicial Services Budget.

8 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham Nation that  
9 it approves the revision of the FY 2001 Judicial Budget.

10 BE IT FURTHER RESOLVED that under Legislative Council Resolution No. 2000-355 the FY 2001  
11 Judicial Branch budget of \$5,271,380.00 be revised to \$5,008,830.00 to be  
12 appropriated and authorized to be expended from sources of funding approved by  
13 this Council for continued support of the FY 2001 budget of the Tohono O'odham  
14 Judicial Branch.


15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day  
16 of FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 2,005.5 FOR; -0-  
17 AGAINST; -0- NOT VOTING; and 160.0 [08] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
19 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
21 Stat. 984).
