

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Increases to the Salary and Fringe Benefit Line Items of the FY 2001
Budget of the Tohono O'odham Judicial Branch)

RESOLUTION NO. 01-060

1 **WHEREAS, the Judicial Branch Children's Programs operate group homes housing certain**
2 **adjudicated child offenders who have been committed to detention; and**

3 **WHEREAS, the group home operations require that a shift supervisor be in attendance during**
4 **each shift; and**

5 **WHEREAS, the group home manager has promoted four of his group home workers to the**
6 **position of shift supervisors. Each promotion was approved by the Chief Judge**
7 **effective October 20, 2000; and**

8 **WHEREAS, the group home shift supervisors are entitled to receive an increased salary in**
9 **accordance with the Tohono O'odham Nation Executive and Judicial Branches salary**
10 **schedule approved by the Tohono O'odham Legislative Council. The new salaries are**
11 **equal to the Juvenile Detention shift supervisor classification; and**

12 **WHEREAS, increases to the salary line item and to the fringe benefit line item of the 2001**
13 **Judiciary Budget are necessary to provide for the payment of the increased salary**
14 **amounts to the new group home shift supervisors. The required increase to the**
15 **salary line item of the FY 2001 Judiciary Budget is \$7,862.00. The required increase**
16 **to the fringe benefit line item is \$2,516.00; and**

17 **WHEREAS, the identified increases will be made available to cover retroactive salary difference**
18 **for the four group home shift supervisors beginning October 20, 2000; and**

19 **WHEREAS, increases to the line items indicated above do not increase the total 2001 Judiciary**
20 **Budget amount approved by the Tohono O'odham Legislative Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
22 **approves the increases to the salary and fringe benefit line items of the FY 2001**
23 **budget of the Tohono O'odham Judicial Branch in the amounts of seven thousand,**
24 **eight hundred sixty-two dollars (\$7,862.00) for salaries and two thousand, five**
25 **hundred sixteen dollars (\$2,516.00) for fringe benefits.**

26 **BE IT FURTHER RESOLVED that the total appropriated amount in Tohono O'odham Legislative**
27 **Council Resolution No. 01-059 for the FY 2001 Budget of the Tohono O'odham Judicial**
28 **Branch remains the same, which includes the above mentioned salary and fringe**
29 **benefit line items.**

6 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
7 **18, 1934 (48 Stat. 984).**


