12 WI	HEREAS,	increases to the salary line item and to the fringe benefit line item of the 2001					
13		Judiciary Budget are necessary to provide for the payment of the increased salary					
14		amounts to the new group home shift supervisors. The required increase to the					
15		salary line item of the FY 2001 Judiciary Budget is \$7,862.00. The required increase					
16		to the fringe benefit line item is \$2,516.00; and					
17 WI	HEREAS,	the identified increases will be made available to cover retroactive salary difference					
18		for the four group home shift supervisors beginning October 20, 2000; and					
19 WI	HEREAS,	increases to the line items indicated above do not increase the total 2001 Judiciary					
20		Budget amount approved by the Tohono O'odham Legislative Council.					
21 NO	OW, THER	EFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation					
22		approves the increases to the salary and fringe benefit line items of the FY 2001					
23		budget of the Tohono O'odham Judicial Branch in the amounts of seven thousand,					
24		eight hundred sixty-two dollars (\$7,862.00) for salaries and two thousand, five					
25		hundred sixteen dollars (\$2,516.00) for fringe benefits.
