RESOLUTION NO. 01-062

1 **WHEREAS, the Baboquivari District Council met on January 25, 2001 to review the Artesia - Little**
2 **Tucson Community FY 99 Supplement budget amendment and modification in the**
3 **amount of thirty seven thousand nine hundred fifteen dollars and eighty five cents**
4 **(\$37,915.85) to be taken from line item 31-7011 750.32 Capital Equipment for the**
5 **creation of one (1) line item namely:**

779.32 SUBCONTRACTOR in the amount of thirty seven thousand nine
hundred fifteen dollars and eighty five cents (\$37,915.85)

JUSTIFICATION - for the construction of Two (2) ADA bathroom additions in
the Community of Little Tucson for two (2) community members.

12 **WHEREAS, any changes in the justification, additions and/or transfer of funds between budget**
13 **line items are to be reviewed and approved by District Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **Artesia-Little Tucson Community FY-99 Supplement Budget new line item 779.32**
16 **Subcontractor.**

17 **BE IT FURTHER RESOLVED that the budget modification in the amount of thirty seven thousand**
18 **nine hundred fifteen dollars and eighty five cents be distributed to new line item in**
19 **the aforementioned.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
21 **of FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**




