

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Charter Membership in the National Indian Gaming Association (NIGA))**

**RESOLUTION NO. 01-064**

1 **WHEREAS, the Tohono O'odham Legislative Council delegated the Legislative Commerce**  
2 **Committee as the oversight on Indian Gaming; and**

3 **WHEREAS, the Commerce Committee has actively participated in the National Indian Gaming**  
4 **Association (NIGA) meetings; and**

5 **WHEREAS, the primary objective and purpose of NIGA is to promote, protect and preserve Indian**  
6 **Gaming enterprises on Indian Country; and**

7 **WHEREAS, the Commerce Committee recommends that the Tohono O'odham Nation renew its**  
8 **membership as a chartered member of NIGA; and**

9 **WHEREAS, the committee further recommends that the Chairman of the Commerce Committee**  
10 **be appointed as the official representative to the NIGA Board of Directors.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **authorizes payment of dues for NIGA membership in the amount of \$25,000.00.**

13 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby appoints the**  
14 **Chairman of the Commerce Committee as the Nation's official Representative to the**  
15 **National Indian Gaming Association Board of Directors.**

16 **BE IT FINALLY RESOLVED that the membership fee of \$25,000.00 to National Indian Gaming**  
17 **Association shall be an operating cost of Desert Diamond Casino and the Nation shall**  
18 **bill Desert Diamond Casino for the annual membership fee to NIGA.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
20 **of FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 1,581.0 FOR; 584.5**  
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (b) & (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**


