(Accepting and supporting the proposal for the Joint Venture Construction Program with Indian Health Service for the Westside Health Clinic and Approval of 30 Acre Land Parcel within Pisinemo District for Westside Health Clinic Construction)

1	WHEREAS,	the Tohono O'odham Legislative Council by Resolution No. 99-082 did accept and
2		support the proposed construction of the Westside Health Clinic through the formal
3		session of the Indian Health Services (I.H.S.) Planning Documents which were jointly
4		developed by the I.H.S. Tucson Area and the Tohono O'odham Health Facilities
5		Planning Task Force; and
6	WHEREAS,	the Tohono O'odham Legislative Council by Resolution No. 99-444 did: (1) appropriate
7		funds for the design and construction (including Project Administration) of the
8		Westside Health Clinic in the amount of \$11,233,514, (2) provided a six month
9		operating budget from February 1, 2000 through September 31, 2000, (3) directed the
10		Nation's Treasurer and Chairman of the Nation to authorize transfer of the
11		appropriated amount into a new account which would earn interest in accordance
12		with the Nation's established investment policies, (4) investigate the placement of the
13		Bond Obligation; and
14	WHEREAS,	the project administration funding for the remainder of FY 2000 and total year 2001
15		(based on FY 2000 salaries-with actual figures to be presented at budget approval for
16		FY 2001) is designated in the amount of \$251,526.80; and
17	WHEREAS,	construction, construction contingency and professional services has been budgeted
18		for \$10,981,987.20 for pre-design, design, site infrastructure, construction and other
19		special engineering studies not foreseen; and
20	WHEREAS,	the Tohono O'odham Legislative Council by Resolution No. 2000-107 did re-authorize
21		Resolution No. 99-444 and approves the appropriated \$11,233,514.00 for the Westside
22		Health Clinic for the Tohono O'odham Nation with the presented budgets for the
23		remainder of FY 2000 and estimated budget for FY 2001; and
24	WHEREAS,	the Pisinemo District did authorize use of the 30 acre parcel within the Pisinemo
25		District via Pisinemo District Resolution No. 2001-01; and
26	WHEREAS,	the Pisinemo District authorized the Tohono O'odham Utility Authority permission

RESOLUTION NO. 01-071 (Accepting and supporting the proposal for the Joint Venture Construction Program with Indian Health Service for the Westside Health Clinic and Approval of 30 Acre Land Parcel within Pisinemo District for Westside Health Clinic Construction) Page 2 of 4 to access the thirty acre parcel to connect and service all utilities on site; and 1 WHEREAS, there are no funds available for staffing or equipment within the proposed Westside 2 3 Health Clinic site; and 4 WHEREAS, by Resolution No. 2000-137, the Tohono O'odham Legislative Council had requested 5 in the year 2000 that I.H.S. appropriate re-occurring patient staffing cost of the 6 Westside Health Clinic for \$2.7 million dollars per year and requests that I.H.S. 7 appropriate initial start up equipment and operation expenses of \$1.8 million 8 dollars; and 9 WHEREAS, the Nation through the Indian Health Service submitted the application and 10 supporting documents to participate in the Joint Venture Construction Program; and WHEREAS, under the Joint Venture Construction Program, a tribe constructs a health care 11 12 facility using non-I.H.S. funds and leases it to I.H.S. at no cost for a period of 20 years. 13 In return, the I.H.S. equips and operates the facility; and WHEREAS, the Tohono O'odham Nation is currently on the I.H.S. construction priority list for an 14 15 outpatient facility; and 16 WHEREAS, tribal Chairman Edward D. Manuel signed a Preliminary Response Form indicating 17 interest to participate in the Joint Venture Construction Program. 18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports and 19 approves the participation in the Joint Venture Construction Program requested by 20 the Nation for the Westside Health Clinic. 21 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council supports and approves the Pisinemo District Resolution No. 2001-01 for approval of 30 Acre Land Parcel 22 within Pisinemo District for Westside Health Clinic Construction and allowing the 23 24 Tohono O'odham Utility Authority to access the thirty acre parcel to connect and 25 service all utilities on site. BE IT FINALLY RESOLVED that the Appropriations Committee is hereby authorized and directed 26 to bring this request to the appropriate Agencies, Members and Committees of 27
