

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'odham Tribal Employment Rights Commission FY 2001 Budget Amendment #1)**

RESOLUTION NO. 01-072

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**  
2 **1978 and has successfully met the needs of the Tohono O'odham; and**  
3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to**  
4 **eradicate employment discrimination within the exterior boundaries of the Tohono**  
5 **O'odham Nation; and**  
6 **WHEREAS, the Tribal Employment Rights Commission is in need of legal representation and has**  
7 **submitted a proposal for two new line items, Professional Services @ \$17,000.00 and**  
8 **Consultant Expenses @ \$3,000.00, for a combined total amount of \$20,000.00; and**  
9 **WHEREAS, the Legislative Council has reviewed this proposal and recommends approval of**  
10 **amendment #1 to the TERO Commission FY 2001 budget in the amount of \$20,000.00.**  
11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the FY 2001 TERO Commission budget amendment #1 and appropriates funds in the**  
13 **amount of \$20,000.00 from the General Fund.**


14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
15 **of FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**


