5		adjudication; and
6	WHEREAS,	the technical work on the program has been performed through a subcontract with
7		the Natural Resources Consulting Engineers of Fort Collins, Colorado; and
8	WHEREAS,	the Tohono O'odham Legislative Council in Resolution No. 2000-191 approved a
9		Professional Services budget of \$100,000 to be expended in the period from October
10		1, 1999 through September 30, 2002; and
11	WHEREAS,	accumulated unspent funds through September 30, 1999 of \$213,135.48 need to be
12		carried over so that they can be expended in accordance with the attached budget
13		modification; and
14	WHEREAS,	the Water Resources Committee and the Budget and Finance Committee of the
15		Legislative Council have reviewed this proposal and recommend approval by the
16		Legislative Council.
17	NOW, THEF	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
18		the savings of \$213,135.48 in the Gila River Adjudication Program of the BIA Master
19		Contract for  expenditure  in  the  period  from  October  1, 1999  through  September  30,
