3	WHEREAS,	the Chairman of the Nation, in consultation with the Budget & Finance Committee
4		has identified a potential candidate to meet the Nation's needs in regard to these
5		lobbying efforts; and
6	WHEREAS,	the Chairman of the Nation, in consultation with the Budget & Finance Committee
7		recommends that the Nation engage the services of Steptoe & Johnson, L.L.P., to focus
8		on lobbying efforts for funding to staff, operate, and maintain a health clinic.
9	NOW, THER	EFORE, BE IT RESOLVED THAT:
10		1. The sum of \$80,000 is hereby appropriated from the general fund for purposes of
11		funding a contract in Fiscal Year 2001 with Steptoe & Johnson in accordance with
12		this Resolution pursuant to a budget of \$8,000 in monthly fees plus \$2,000 per
13		month for out-of-pocket expenses.
14		2. The Chairman of the Nation is hereby authorized and directed to execute an
15		agreement substantially in the form attached hereto with the firm of Steptoe &
16		Johnson selected in accordance with this Resolution.
17		3. For purposes of administration of the agreement, the Chairman of the Nation
18		shall be the primary contact with the firm for purposes of directing the work of
19		the firm.
20		4. Any amendments to the agreement affecting the funding levels of the agreement
21		shall be submitted for further prior approval by the Legislative Council.
