RESOLUTION NO. 01-090

1 **WHEREAS, Legislative Order No. 138-90 created the Appropriations Committee as a standing**
2 **committee of the Legislative Council to follow up on the Federal Congressional**
3 **Appropriations process and the Nation's priorities; and**

11 **the Nation's programs and departments various proposed funding requests for FY**
12 **2002 Federal Appropriations; and**

13 **WHEREAS, funding requests will be submitted to the appropriate Congressional committees,**
14 **representatives and federal agencies in Washington, DC.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **authorize the Appropriations Committee to testify and lobby on behalf of the Tohono**
17 **O'odham Nation for FY 2002 appropriations funding requests.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
19 **of FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 1,999.6 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 165.9 [04] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**


