

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting Special Session dates of April 26 & 27, 2001 for Disenrollment Hearings and  
April 16, 2001 for Mandatory Workshop on Enrollment Ordinance)**

**LEGISLATIVE ORDER NO. 01-091**

1 **WHEREAS, during the February 28, 2001 Special Session on FY 2002 federal appropriations**  
2 **requests, the Rules Committee did request that the Legislative Council establish**  
3 **special session dates as follows: April 16, 2001 - Enrollment Ordinance Workshop and**  
4 **April 26 & 27, 2001 - Disenrollment Hearings; and**

5 **WHEREAS, the Rules Committee has recommended mandatory attendance of Councilmembers**  
6 **for the Enrollment Ordinance Workshop and the Disenrollment Hearings.**

7 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
8 **establishes special session dates as follows:**

9 **April 16, 2001 Enrollment Ordinance Workshop**

10 **April 26 & 27, 2001 Disenrollment Hearings.**

11 **BE IT FURTHER ORDERED that Councilmembers are hereby mandated to attend the Enrollment**  
12 **Ordinance Workshop and the Disenrollment Hearings.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day of**  
14 **FEBRUARY, 2001 at a meeting at which a quorum was present with a vote of 1,830.75 FOR; -0-**  
15 **AGAINST; 168.85 NOT VOTING; and 165.9 [04] ABSENT, pursuant to the powers vested in the Council**  
16 **by Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**
