

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 01-053, "Approving Malita Liston to
Tohono O'odham Election Board")

RESOLUTION NO. 01-122

- 1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint members**
2 **of the Tohono O'odham Election Board pursuant to Section 1(B) of Article II of**
3 **Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"); and**
4 **WHEREAS, Section 1(B) further states that "[m]embers of the Election Board shall be appointed**
5 **by the Tohono O'odham Council for terms of five years, or until their successors are**
6 **appointed and qualified"; and**
7 **WHEREAS, effective July 31, 1999, Election Board Member Felix Martin's term did expire, but he**
8 **continued to serve as a Board member pending his successor's appointment; and**
9 **WHEREAS, on February 8, 2001, the Legislative Council passed Resolution No. 01-053 appointing**
10 **Malita Liston to the Election Board to complete the five year term ending July 31,**
11 **2004; and**
12 **WHEREAS, Resolution No. 01-053 was neither approved nor disapproved by the Nation's**
13 **Chairman within forty-eight (48) hours after being submitted and, therefore, became**
14 **effective on February 12, 2001; and**
15 **WHEREAS, on February 12, 2001 at 4:53 p.m., Malita Liston faxed a letter to the Legislative**
16 **Chairman stating that she had decided to withdraw her name as a an Election Board**
17 **candidate and did not wish to serve in this capacity; and**
18 **WHEREAS, because Malita Liston does not wish to serve on the Election Board, it is necessary to**
19 **rescind her appointment and seek a successor to Felix Martin, who will return to the**
20 **Election Board until a successor is appointed to the term ending July 31, 2004.**
21 **NOW, THEREFORE, BE IT RESOLVED, the Legislative Council hereby rescinds Resolution No.**
22 **01-053, "Appointing Malita Liston to Tohono O'odham Election Board."**
23 **BE IT FINALLY RESOLVED, the Legislative Council hereby directs the Rules Committee to**
24 **advertise the Election Board seat with a term ending July 31, 2004 and otherwise**
25 **process candidate applications so that Felix Martin's successor may be appointed**
26 **as soon as possible.**
