

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Addition)**

RESOLUTION NO. 01-132

1 **WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham Nation provides**
2 **that the Tohono O'odham Council can make additions and changes to the official**
3 **census rolls of the Sells and Gila Bend Reservations dated January 1, 1937 and of the**
4 **San Xavier Reservation dated January 1, 1940, subject to the approval of the Secretary**
5 **of the Interior; and**

6 **WHEREAS, the Enrollment Committee has determined that the following named person(s) was**
7 **a member of the Tohono O'odham Nation on the date of the respective census rolls**
8 **but that their name(s) had been inadvertently omitted therefrom, and had**
9 **recommended that their name(s) be added to the rolls; and**

10 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment**
11 **Committee and approves thereof.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to the approval**
13 **of the Secretary of the Interior, the name(s) of the following person(s) be added to the**
14 **official census rolls of the Sells, Gila Bend or San Xavier Reservation to wit:**

2183-GV-01 CELAYA de VALDEZ, Teresa

1919-GV-01 ALVAREZ, Cresencio R.

17 **BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the**
18 **Interior before their name(s) be formally added to such rolls.**

19 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 02ND Day**
20 **of APRIL, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(a) of**
22 **Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
23 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




