6 **hereby recognize that the above-named person(s) have relinquished their**
7 **membership in this Nation, and does hereby order that their name(s) be deleted from**
8 **the membership roll.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
11 **of APRIL, 2001 at a meeting at which a quorum was present with a vote of 1,831.7 FOR; 254.75**
12 **AGAINST; 79.05 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
13 **Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**
14 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
15 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
16 **of June 18, 1934 (48 Stat. 984).**
