

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Legislative Order No. 01-091 "Setting Special Session Dates of April 26 & 27,  
2001 for Disenrollment Hearings and April 16, 2001 for Mandatory Workshop on  
Enrollment Ordinance" to Cancel April 26-27, 2001 Disenrollment Hearing)**

**LEGISLATIVE ORDER NO. 01-135**

1 **WHEREAS, on March 09, 2001, the Legislative Council adopted Legislative Order No. 01-091**  
2 **establishing the dates of April 16, 2001 for an Enrollment Workshop and April 26-27,**  
3 **2001 to conduct Disenrollment Hearings; and**

4 **WHEREAS, the Rules Committee, which has oversight of Enrollment issues, has been informed**  
5 **that one of the Enrollment Committee members has a scheduling conflict and would**  
6 **not be able to attend the April 26-27, 2001 Disenrollment Hearings; and**

7 **WHEREAS, the Enrollment Director has also informed the Rules Committee that necessary**  
8 **relinquishment paperwork from the Gila River Indian Community and other tribes**  
9 **whose members are also enrolled with the Tohono O'odham Nation have not been**  
10 **received; and**

11 **WHEREAS, a recommendation was made that the Legislative Council cancel its scheduled April**  
12 **26-27, 2001 Disenrollment Hearings for the reasons provided.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
14 **amends Legislative Order No. 01-091 to cancel the April 26-27, 2001 Disenrollment**  
15 **Hearings.**

16 **BE IT FURTHER ORDERED that the Enrollment Office shall notify individuals scheduled**  
17 **for the April 26-27, 2001 hearings of the cancellation.**

18 **BE IT FINALLY ORDERED that the April 16, 2001 Enrollment Workshop will be held as scheduled.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup> Day of**  
21 **APRIL, 2001 at a meeting at which a quorum was present with a vote of 1,910.75 FOR; 149.95**  
22 **AGAINST; 104.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 1 (l) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
