

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 01-141, "Adopting the Charter and Funding Plan for the**  
**Economic Development Authority of the Tohono O'odham Nation and**  
**Appropriating \$10.5 Million as its Initial Capital')**

RESOLUTION NO. 01-142

1 WHEREAS, the Tohono O'odham Legislative Council supports the intent of Resolution No. 01-141  
2 in establishing the Economic Development Authority by approving its charter and  
3 appropriation of funds; and

4 WHEREAS, concerns were raised on establishing the Economic Development Authority as a  
5 separate entity of the Nation; and

6 WHEREAS, by amending Resolution No. 01-141 it would create the Economic Development  
7 Authority as an entity of the Nation.

8 NOW, THEREFORE, BE IT RESOLVED that the amendment of Resolution No. 01-141 hereby  
9 creates the Economic Development Authority as a separate entity of the Tohono  
10 O'odham Nation.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day  
12 of APRIL, 2001 at a meeting at which a quorum was present with a vote of 1,407.7 FOR; 573.95  
13 AGAINST; 183.85 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
14 Section 1 (d)(2) & (e) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
15 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).


