

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Title III CILC Funds July 01, 2000 - June 30, 2001)

RESOLUTION NO. 01-149

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**
4 **part by Title III of the Older American's Act of 1965 as amended, through the**
5 **Administration of the Inter-Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the Nation receives Cash in Lieu of Commodities (CILC) from USDA through ITCA**
7 **based on the number of eligible meals served; and**

8 **WHEREAS, the services provided to elderly members has been beneficial and services continue**
9 **to be necessary to provide nutrition and socialization support; and**

10 **WHEREAS, the Senior Services Program has prepared a budget for FY 2001 Title III to utilize CILC**
11 **funds to purchase food items only, as required by law.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council,**

13 **1. That it hereby approves the FY 2001 Title III CILC budget for the Elderly Program**
14 **to continue to provide such services it has proposed per attachments in light of**
15 **the requirements and regulations.**

16 **2. The Tohono O'odham Nation officials to wit: The Chairman is hereby authorized**
17 **to negotiate and execute the grant, provided however, that any amendments**
18 **affecting the funding or funding levels of this contract shall be submitted for**
19 **further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03rd. Day**
21 **of APRIL, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
22 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
23 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




