Budget to Reflect the Increase of In-Kind/Match Contribution from the Tohono O'odham
Nation from \$32,706.80 to \$35,538.00)

RESOLUTION NO. 01-151

- 1 **WHEREAS, the Tohono O'odham Legislative Council previously supported the Nation's Education**
2 **Department to submit a grant proposal and establish a vocational rehabilitation**
3 **program under Resolution No. 98-202; and**
- 4 **WHEREAS, the Tohono O'odham Nation was awarded a grant under Rehabilitation Services**
5 **Administration's Section 121 (Vocational Rehabilitation Services Projects for**
6 **American Indians with Disabilities) of the Rehabilitation Act and received grant**
7 **notification number H250G980011; and**
- 8 **WHEREAS, services will be provided to eligible American Indians with Disabilities under the**
9 **Tohono O'odham Nation's Vocational Rehabilitation Program, who reside on or near**
10 **the Tohono O'odham Nation with enrolled Tohono O'odham members being first**
11 **priority; and**
- 12 **WHEREAS, near is defined as: Gila Bend, Ajo, Why, Lukeville, Robles Junction, Eloy, Coolidge,**
13 **Casa Grande and Stanfield; and**
- 14 **WHEREAS, the services provided will be consistent with individual strengths, resources,**
15 **priorities, concerns, abilities, capabilities and informed choice of eligible American**
16 **Indians so that they may prepare for and engage in gainful employment; and**
- 17 **WHEREAS, the Tohono O'odham Nation's Vocational Rehabilitation Program FY 2001 Budget was**
18 **approved by the Tohono O'odham Legislative Council in the amount of \$327,068.00**
19 **which also shows the In-Kind/Match Contribution from the Tohono O'odham Nation**
20 **as \$32,706.80; and**
- 21 **WHEREAS, the Tohono O'odham Nation's Vocational Rehabilitation Program has received the**
22 **U.S. Department of Education, Office of Special Education and Rehabilitative Services**
23 **in Washington, DC Grant Award Notification which reflects the In-Kind/Match**
24 **Contribution from the Tohono O'odham Nation as \$35,538.00.**
- 25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the**
26 **change of In-Kind/Match Contribution from the Tohono O'odham Nation to reflect**
27 **\$35,538.00 instead of \$32,706.80.**
- 28 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation's Vocational Rehabilitation**

2 **only the In-Kind/Match Contribution Funds are to be revised.**

3 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
4 **Nation's Officials, to wit: the Chairman and any designated official are hereby**
5 **authorized to execute and expend the grant award and provide continued culturally**
6 **appropriate vocational rehabilitation services to its eligible consumers, provided**
7 **however that any amendments affecting the funding or funding levels of this grant**
8 **shall be submitted for further approval.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
10 **of APRIL, 2001 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**
11 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
12 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
