

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting April 12, 2001 Special Session to Hear Appeal by Harriet Toro of Chukut Kuk
District's Adjustment of Its Schedule of Representatives)**

LEGISLATIVE ORDER NO. 01-152

1 **WHEREAS, Article VI, Section 1(g) of the Constitution of the Tohono O'odham Nation delegates**
2 **the Legislative Council authority "to enact laws and ordinances for conducting and**
3 **regulating elections"; and**

4 **WHEREAS, the Uniform Election Ordinance ("Election Ordinance") was enacted as Ordinance No.**
5 **03-86 on December 4, 1986; and**

6 **WHEREAS, Article VI, Section 3(B) of the Election Ordinance states "any member of the nation**
7 **residing in a district, may appeal [a] district's schedule [of representatives] to the**
8 **Tohono O'odham Council at least sixty (60) days prior to the election. The Tohono**
9 **O'odham Council shall, if necessary, call a special meeting to decide such appeals,**
10 **and its decision shall be final."; and**

11 **WHEREAS, on March 27, 2001, sixty (60) days prior to the May 26, 2001 general election, Harriet**
12 **Toro did deliver to the Legislative Administration Office an appeal of the Chukut Kuk**
13 **District's adjustment of its schedule of representatives; and**

14 **WHEREAS, Harriet Toro, the Chukut Kuk District Council, and other individuals who may be**
15 **called as witnesses require sufficient notice before the Council can meet to hear this**
16 **appeal; and**

17 **WHEREAS, it is therefore necessary to set a special session to hear Harriet Toro's appeal.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that a**
19 **Special Session is set for April 12, 2001 to hear Harriet Toro's appeal of the Chukut**
20 **Kuk District's amendment of its schedule of representatives.**

21 **BE IT FURTHER ORDERED that notices shall be sent to Harriet Toro and the Chairman of**
22 **the Chukut Kuk District Council, notifying them of the Special Session, and their**
23 **rights to be present, to be heard, to call witnesses, and present relevant evidence.**

24 **BE IT FINALLY ORDERED that the scope of the April 12, 2001 Special Session shall be limited**
25 **to the appeal of the Chukut Kuk District Council's adjustment of its schedule of**
26 **representatives.**
