

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the Attorney Contract with California Indian Legal Services)**

RESOLUTION NO. 01-169

1 WHEREAS, by Resolution 2000-496, the Tohono O'odham Legislative Council approved an  
2 Attorney Contract with California Indian Legal Services to provide legal  
3 representation to the Nation in connection with certain cases pending in California  
4 under the Indian Child Welfare Act; and

5 WHEREAS, the Attorney Contract is in the amount of \$34,000 for fiscal year 2001; and

6 WHEREAS, the additional sum of \$32,000 is required for legal fees and expenses to assure  
7 uninterrupted legal representation for fiscal year 2001; and

8 WHEREAS, sufficient funds are available in the budget of the Office of Attorney General to  
9 supplement the Attorney contract by such amount; and

10 WHEREAS, the Domestic Affairs Committee recommends approval of Amendment No. 1 to the  
11 Attorney Contract to increase the Contract amount by \$32,000.

12 NOW, THEREFORE, BE IT RESOLVED THAT:

13 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to  
14 the Attorney Contract with California Indian Legal Services in the form attached  
15 hereto, which increases the Contract amount by \$32,000 payable from the fiscal  
16 year 2001 operating budget of the Office of Attorney General.

17 2. The Chairman of the Nation is authorized and directed to execute Amendment No.  
18 1 to such Contract.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day  
20 of APRIL, 2001 at a meeting at which a quorum was present with a vote of 1,595.35 FOR; 570.15  
21 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
22 Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
23 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat. 984).


