

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the law firm of Quigley and Whitehill, P.L.C.)**

RESOLUTION NO. 01-170

1 **WHEREAS, on October 14, 1999, by Resolution No. 99-585, the Legislative Council approved a**
2 **comprehensive plan for intergovernmental and public relations for fiscal year 2000,**
3 **and adopted a budget to implement the approved plan; and**

4 **WHEREAS, by Resolution No. 99-585, the Legislative Council appropriated \$475,000.00 to the**
5 **operating account of the Office of the Attorney General, in accordance with the**
6 **adopted budget to implement the approved plan; and**

7 **WHEREAS, to implement Resolution No. 99-585, the Legislative Council approved by Resolution**
8 **No. 2000-214 an Attorney Contract with the law firm of Quigley, Tang and Whitehill,**
9 **P.L.C. (now known as Quigley and Whitehill, P.L.C.); and**

10 **WHEREAS by Resolution No. 2000-467, the Legislative Council authorized that the funds**
11 **available under Resolution No. 99-585 continue through Fiscal Year 2001 for the**
12 **purposes and efforts therein specified until such time as the funds are expended; and**

13 **WHEREAS the Office of Attorney General, in consultation with the Chairman of the Nation and**
14 **the Commerce Committee, recommends re-contracting with the law firm of Quigley**
15 **and Whitehill, P.L.C., for fiscal year 2001 in the amount of \$100,000.00; and**

16 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
17 **an Attorney Contract with the Attorneys on such terms.**

18 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 19 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
20 **with the law firm of Quigley & Whitehill, P.L.C., in the amount of \$100,000.00 for**
21 **fiscal year ending September 30, 2001 and in the form attached hereto.**
- 22 **2. Funding for the Attorney Contract shall be provided under the operating budget**
23 **of the Office of Attorney General for fiscal year 2001, account number 1-4236-810.**
- 24 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
25 **Contract.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
27 **of APRIL, 2001 at a meeting at which a quorum was present with a vote of 1,531.3 FOR; 570.15**
28 **AGAINST; 64.05 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
