

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Granting Appeal from the Chukut Kuk District's Adjustment of Its Schedule of
Representatives and Declaring Adjustment Invalid)**

**DENIED
LEGISLATIVE ORDER NO. 01-177**

1 **WHEREAS, Article VI, Section 1(g) of the Constitution of the Tohono O'odham Nation delegates**
2 **the Legislative Council authority "to enact laws and ordinances for conducting and**
3 **regulating elections"; and**

4 **WHEREAS, the Uniform Election Ordinance ("Election Ordinance") was enacted as Ordinance No.**
5 **03-86 on December 4, 1986; and**

6 **WHEREAS, Article VI, Section 3(B) of the Election Ordinance states "any member of the nation**
7 **residing in a district, may appeal [a] district's schedule [of representatives] to the**
8 **Tohono O'odham Council at least sixty (60) days prior to the election. The Tohono**
9 **O'odham Council shall, if necessary, call a special meeting to decide such appeals,**
10 **and its decision shall be final."; and**

11 **WHEREAS, on March 27, 2001, sixty (60) days prior to the May 26, 2001 general election, Harriet**
12 **Toro did appeal the Chukut Kuk District's February 14, 2001 adjustment of its**
13 **schedule of representatives to the Legislative Council; and**

14 **WHEREAS, on April 3, 2001, the Legislative Council by Legislative Order No. 01-152 did set a**
15 **hearing for April 12, 2001 to consider Harriet Toro's appeal; and**

16 **WHEREAS, on April 12, 2001, the Legislative Council convened an appeal hearing in the**
17 **Legislative Council Chambers, heard and considered the arguments and evidence for**
18 **and against the appeal, and reviewed documents relevant to the schedule**
19 **adjustment.**

20 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**
21 **hereby finds the Chukut Kuk District's February 14, 2001 adjustment to its schedule**
22 **of representatives was invalid and that the adjustment is therefore void.**

23 **BE IT FURTHER ORDERED by the Tohono O'odham Legislative Council that it**
24 **hereby grants Harriet Toro's appeal from the Chukut Kuk District's February 14,**
25 **2001 adjustment of its schedule of representatives.**

26 **BE IT FINALLY ORDERED that the Chukut Kuk District's official schedule of representatives shall**
27 **be the schedule last certified to the Election Board prior to the District's February 14,**
28 **2001 adjustment.**


1 The foregoing decision of the Tohono O'odham Legislative Council was rendered on the 12th Day

6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat. 984).
